How to become Flight Instructor | Flying Academy

Know what it takes to become an instructor. There are several tests required to become a flight or ground instructor, including the Fundamentals of Instructing (FOI) knowledge test, and a test specific to the type of instructor certificate you are seeking. This includes Flight Instructor Airplane (FIA), Sport Pilot Flight Instructor (SIA), Basic Ground Instructor (BGI), Advanced Ground Instructor (AGI), or Instrument Ground Instructor (IGI).
