About this guidance Published in April 2011, this guidance provided clear and practical advice for dentists in primary care on how to provide care for patients prescribed bisphosphonate drugs. The guidance was placed under review in 2015 and an update, retitled Oral Health Management of Patients at Risk of Medication-related Osteonecrosis of the Jaw , was published in 2017.

Definitive treatment for a dental abscess should be provided by a dentist. Interim treatment (whilst waiting to see a dentist) consists of: Self-care advice to reduce the pressure and pain of the dental abscess. Analgesia (ibuprofen or paracetamol) to relieve symptoms.
